Dear Madam or Sir,

I am writing in response to your letter of July 11<sup>th</sup> stating that I owe a \$400.00 late fee. On July 5, I received a letter from you stating that my S-corporation would be dissolved if I didn't pay an annual \$150.00 profit report. As I had not received any kind of notification that the report or \$150.00 was due, I took the notice to my accountant (Albert Cummins III, Gainesville; telephone (352) 375 6608) on the same day. (This has been my first year as a corporation, so I do not have a history of handling the paperwork for a corporation.)

In my presence, Mr. Cummins called your office and asked what I needed to do in light of not having received the notification. You had him download the appropriate papers, which I filled out and mailed, along with \$150.00, the same day, July 5<sup>th</sup>. We were not informed that any late fee was applicable, nor would it have made sense for there to be one, since I never received your initial notice.

On July 6<sup>th</sup>, I left the country and did not return until August 25<sup>th</sup> (travel documents available if needed.) I found your letter of July 11<sup>th</sup> when I opened my mail August 26<sup>th</sup>, and it came as a surprise given that I thought the matter had been settled on July 5<sup>th</sup>.

I would appreciate your review of my case.
