The name of the proposed corporation shall be Sergio Ramirez Painting, Inc.

ARTICLE 2

The principal place of business and mailing address of the corporation is 236 Bay Street, Fellsmere, FL 32948

ARTICLE 3

The general nature of the business to be transacted by the corporation will include, but is not limited to, the painting of homes, business, and other structures as requested by the customers. 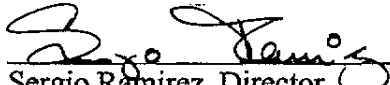

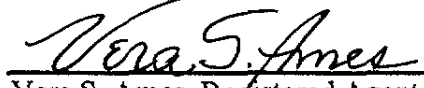
