

ARTICLES OF INCORPORATION OF WATER DUCKS, INC.

ARTICLE I NAME

The name of this corporation is WATER DUCKS, INC.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of filing these Articles with the Department of State.
