I greatly appreciate your phone call on Wednesday afternoon regarding our discussion to resolve the referenced issue. I would like to formally state that SunCapital Development Group, Inc. did not receive the 2005 Annual Report Documents from the State of Florida which are to be filed with the Divisions of Corporations on a timely sensitive annual basis.

You office received the proper 2005 Annual Report documents which accompanied our payment in the amount of \$158.75 check # 1012 was pulled off line, filed out and mailed to the State of Florida upon receiving the attached letter from Corporate Compliance Center.

Again, the initial confusion was created by the group referred to as Corporate Compliance Center who provided a misleading mock Annual Report form document to be completed and returned with payment. SunCapital Development Group efforts to file on time directly with the State was compromised since I was led to believe this organization was affiliated with the State of Florida and was collecting annual reports & fees. I completed the mock form provided by this organization and sent payment on 5/10/05 as instructed by this organization. I received the attached letter dated 8/25/05 from this organization returning my payment. The attached letter states the prepared Annual Report had not been forwarded to the Secretary of State and the Secretary of State would waive tate filing fees for those who submitted their Annual Report in response to the referenced mailing. Please see last paragraph in the attached letter.

I trust this information provides sufficient documentation to waive the late filing fee imposed against SunCapital Development Group, Inc. I greatly appreciate your consideration to rectify our good faith efforts to file properly with the State and I hope this resolves this issue. I await your formal notice to this effect.
