OLAPRIED PH 5:43 The undersigned, hereby associate ourselves together for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do hereby certify that we have become such corporation under and pursuant to the following Articles of Incorporation:

ARTICLE I

The name of the corporation is ACE CYCLES, INC., located at 200 North French Avenue, Sanford, Florida 32771.

ARTICLE II

The general nature of the business to be transacted by said corporation shall be and is as follows:

To provide repair service for motorcycles.
