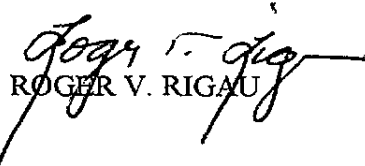

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is B & B ENTERPRISES OF TAMPA, INC.

ARTICLE II

The corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III

The corporation may engage in any activities or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

The initial post office address of the principal office of this corporation in the State of Florida is 14825 N. Nebraska Avenue, Tampa, FL 33613. The Board of Directors may from time to time move the registered office to any other address in Florida.

ARTICLE V

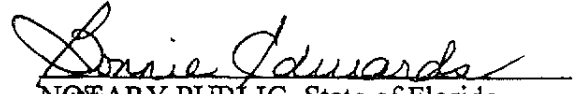

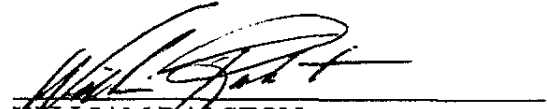

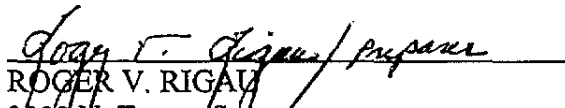
