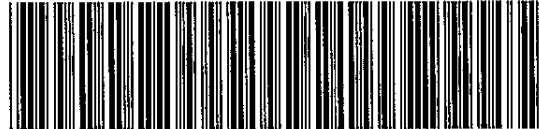

ARTICLE I.

Incorporators




