

The undersigned incorporators to these Articles of TALLAHASSEE FLORIDA Incorporation, natural persons competent to contract, hereby subscribe and form a corporation for profit under the Laws of the State of Florida.

ARTICLES I - NAME

The name of the corporation is AWARD MARKETING GROUP INC.

ARTICLE II - NATURE OF BUSINESS


