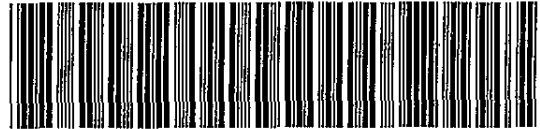

THE UNDERSIGNED incorporator hereby forms a Professional Association under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

BRAD HACKER, C.P.A., P.A.

ARTICLE II. PRINCIPAL OFFICE

The address of the principal office of this Corporation shall be 10808 Nashville Drive, Cooper City, FL 33026, and the mailing address of the Corporation shall be the same.

ARTICLE III. PURPOSE

The corporation is organized for the following purposes:

A. To engage in the practice of accounting as a professional corporation.

B. This Corporation shall exist perpetually.

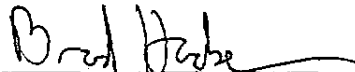

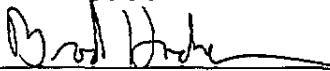
