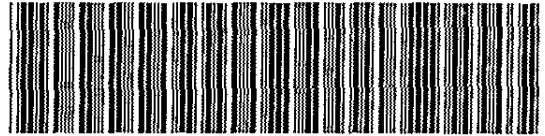

ARTICLE I



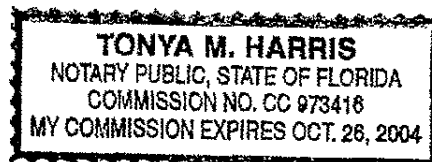
