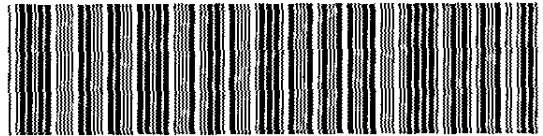

The name of the corporation shall be:


ARTICLE VII
