ARTICLES OF INCORPORATION OF P & G PRINTING COMPANY, INC.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. Name

The name of the Corporation is P & G Printing Company, Inc.

II. Term of Existence

The Corporation's existence commences on the date of the filing of these Articles of Incorporation with the Department of State of the State of Florida. The Corporation will have perpetual existence thereafter.

III. Principal Office

The principal office and mailing address of the Corporation is 1724 Gulf To Bay Boulevard, Clearwater, Florida 33755.

IV. Nature of Business and Purposes

The purpose for which the Corporation is organized is to provide commercial printing services, and to conduct any and all business in connection therewith.

V. Capital Stock

The Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which will be designated Common Stock.
