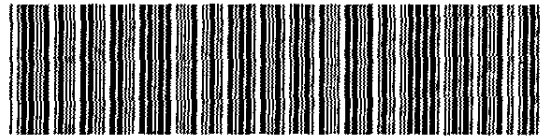



OF

BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation for profit under Florida law.

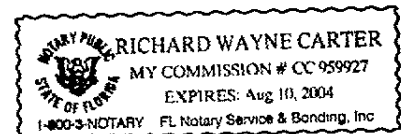
