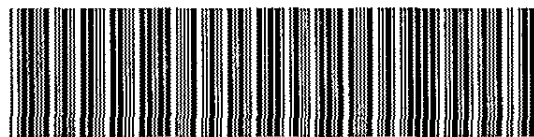

ARTICLES OF INCORPORATION OF THE SPECIALISTS IN COMMERCIAL FLOORING,  
INC.

The undersigned hereby adopt the following articles of incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I-NAME

The name of the corporation is The Specialists in Commercial Flooring, Inc. The principal address of the corporation is 11300 Space Blvd., Orlando, Florida 32837.

ARTICLE II- COMMENCEMENT AND TERMINATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgment of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III- PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the United States of America.

ARTICLE IV- STATED CAPITAL

The maximum number of shares which a corporation is authorized to have outstanding at any one time is 5,000 shares of common stock. The par value shall be \$1.00 per share.

ARTICLE V- INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be 11300 Space Blvd., Orlando, Florida 32837, and the initial registered agent of this corporation in such office shall be Luis Gonzalez who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time with respect to keeping an office open for service of process.

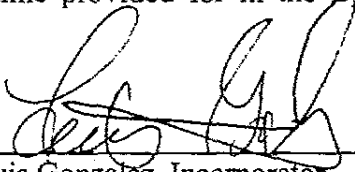

#### ARTICLE IX- LOST OR DESTROYED CERTIFICATES

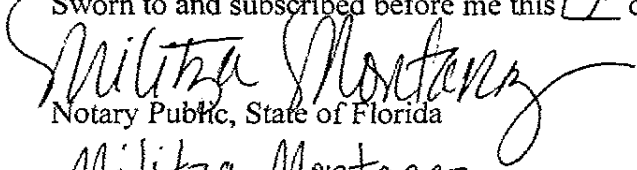
Stock certificates to replace lost or destroyed certificates shall be issued on such basis and according to such procedures as are from time to time provided for in the By-Laws of the corporation.
