ARTICLES OF INCORPORATION OF LOT & LAND OF SOUTHWEST FLORIDA, INC. 1081

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

ARTICLE 1. NAME

The name of this corporation shall be named and known as LOT & LAND OF SOUTHWEST FLORIDA, INC.

ARTICLE 2. DURATION.

The corporation shall commence upon the filing of these Articles of Incorporation and shall have perpetual existence thereafter.

ARTICLE 3. PURPOSE.

The purpose for which the corporation is organized is the transaction of any and all lawful business for which a corporation may be incorporated under the Florida General Corporation Act, as the same may from time to time be amended.

ARTICLE 4. CAPITAL STRUCTURE.

The number of the members of the Board of Directors may either be increased and decreased from time to time by Bylaws, but shall never be less than one (1). 
