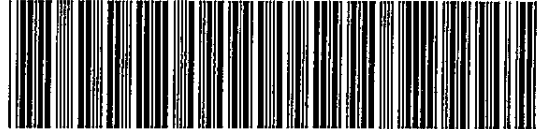

Articles of Incorporation

ARTICLES OF INCORPORATION
OF

KINGS DEVELOPMENT, INC.
A Florida Corporation

ARTICLE I
NAME

The name of the Corporation is: KINGS DEVELOPMENT, INC., a domestic corporation, which is not a member of any affiliated group.

ARTICLE III
PURPOSE


