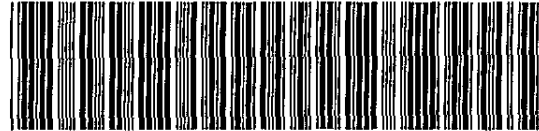

ARTICLE ONE
