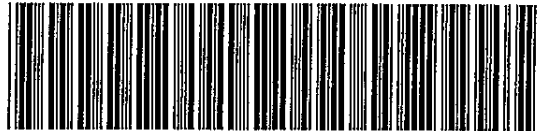



ARTICLES OF INCORPORATION

OF

DON DEDERT, INC.

ARTICLE I

The name of the corporation is DON DEDERT, INC.

ARTICLE II

This corporation shall have perpetual existence, commencing as of the time these ARTICLES are filed by the Department of State, Division of Corporations.
