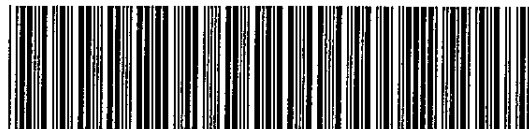

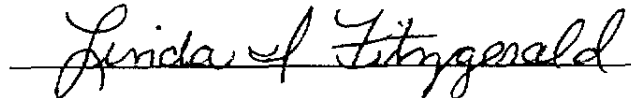

OF

ARTICLE I NAME

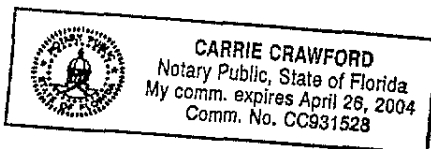
