





ARTICLE I-Name

The name of this corporation is All About Lawns, Inc.

ARTICLE II- Principal Office

The address of the principal office is 1203 Robin Terrace, Sebring, Florida 33875, and a mailing address of 1203 Robin Terrace, Sebring, Florida 33875.

ARTICLE III-Duration

This corporation shall have perpetual existence.


