**ARTICLE I**  
**Name and Duration**

The name of the Corporation is FEIZ HOLDINGS, INC. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed by the Secretary of State.

**Registered Office and Agent**

**Corporate Purposes, Powers and Rights**
