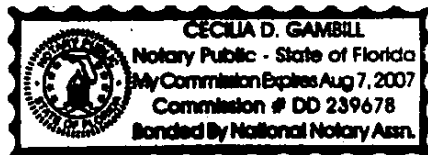
1. Teresa Austin is the President of FLEMING ISLAND PHOTOGRAPHY, INC., a Florida corporation, (hereinafter "Corporation").
