ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "BEACH STREET PLUMBING, INC.". The principal location of the corporation is 934 South Beach Street, Daytona Beach, Florida 32114.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of plumbing services and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.


