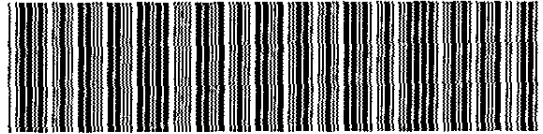

ARTICLES OF INCORPORATION
OF
THUNDERBIRD UTILITY, INC.

The undersigned natural person acting as incorporator of a corporation (the "Corporation") under the laws of the State of Florida, adopts the following Articles of Incorporation.




