The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation in accordance with the laws of the State of Florida.

ARTICLE I. - NAME

The name of this corporation is DON SCHAFFTER INC.

ARTICLE II. -NATURE OF BUSINESS

The general nature of the business to be rendered by this corporation is any lawful purpose permitted by the laws of the State of Florida.

ARTICLE III- CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Two Hundred (200) shares of stock having a par value of One Dollar (\$1.00) per share.

ARTICLE IV. - INITIAL CAPITAL

The amount of capital with which this corporation will begin business is One Thousand (\$1,000.00) Dollars.

ARTICLE V. -TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI. -INCORPORATORS AND CORPORATE ADDRESS

The incorporator's name is DON SCHAFFTER and the initial address of the principal office of this corporation is: 1720 Kamsack Street NW, Palm Bay, Florida 32907.

ARTICLE VII. - REGISTERED AGENT

ARTICLE VIII. - DIRECTORS

outstanding shares of this corporation by any of its Shareholders, or the operation of this

corporation, or in the event of the death of any of its Shareholders. The manner and form, as

well as relevant terms, conditions and details hereof, shall be determined by the Shareholders

of this corporation; provided, however, that such regulatory or restrictive provisions shall

not affect the rights of third parties without actual notice thereof, unless existence of such

provisions shall be plainly written upon the certificate evidencing the ownership of said

stock.

ARTICLE XI. - VOTING TRUSTS

No shareholder of this corporation shall enter into a voting trust agreement or any

other type of agreement vesting in another the authority to exercise the voting power of any

or all of his shares.
