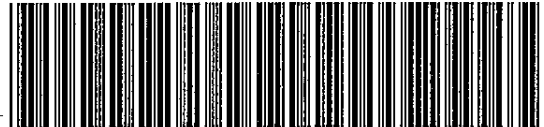


ARTICLE XI - MEETINGS
