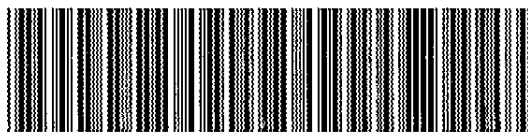

The name of this Corporation is HINOTE WELDING OPS, INC.
