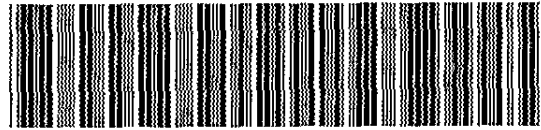

The general nature of the business and the object and purposes to be transacted and  
carried on are:


