The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be:

SOUTH FLORIDA BRICK & STONE COMPANY

ARTICLE II

The period of duration of the corporation shall be perpetual.


ARTICLE VI

The Board of Directors shall have the authority to adopt and periodically amend the bylaws of the Corporation. Further powers of the Board shall be defined in the By-Laws.


