ARTICLES OF INCORPORATION

ARTICLE I
CORPORATE NAME

The name of the corporation is COURTYARD GRECO CONSTRUCTION & DESIGN, INC.

DURATION

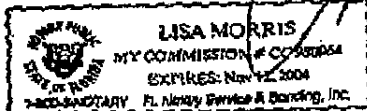


