THE UNDERSIGNED, acting as sole incorporator of 3 TAYLORS HOLDINGS, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is 3 Taylors Holdings, Inc.

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (50,01) par value per share.
