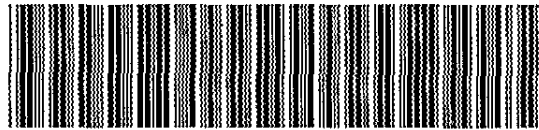

CORPORATE NAME**

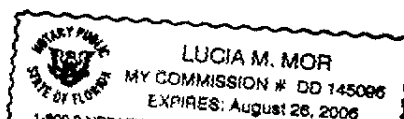


