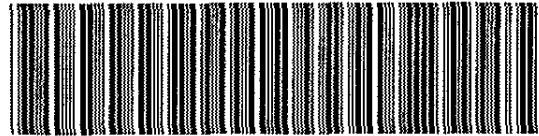

**FIRST: Amendments Adopted:**

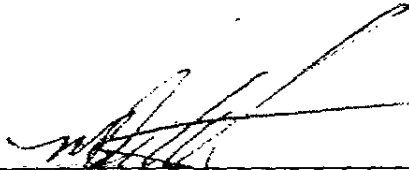
Article One: The corporate name is hereby changed to:
