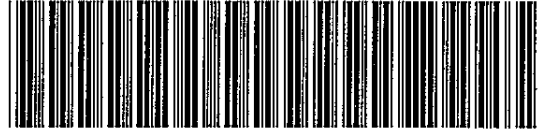

ARTICLES OF INCORPORATION  
OF  
PARADISE FISHING CHARTERS, INC.

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE ONE  
NAME

THE NAME OF THE CORPORATION IS PARADISE FISHING CHARTERS, INC.

DURATION
