

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is CARRIAGE HOUSE HOMES, INC.

ARTICLE II - DURATION

This corporation shall exist in perpetuity commencing on the date set forth in Article XIII of these Articles.
