The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I
Name and Principal Office of Corporation

The name of this Corporation shall be DiSam Industries GP, Inc. The initial mailing address of the Corporation shall be 1490 Frances Drive, Daytona Beach, Florida 32124.

ARTICLE II
Nature of Business
