## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION N-VIA USA, INC. a Florida corporation



Pursuant to the provisions of section 607.1006 of the Florida Business Corporation Act, Article III of the Articles of Incorporation of N-VIA USA, INC., a Florida corporation filed on April 26, 2004, under Document # P04000068156, hereinafter referred to as the "Corporation," is amended to read as follows:

## "ARTICLE III - CAPITAL STOCK:

The number of shares that the Corporation is authorized to issue is TWENTY MILLION (20,000,000), all of which shall be "common stock", \$0.001 par value per share. Each issued and outstanding share of common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders."

The amendment was approved by the sole shareholder on October 16 th., 2007, and the number of votes cast for the amendment was sufficient for approval.
