**ARTICLES OF INCORPORATION

ARTICLE I - NAME AND BUSINESS ADDRESS

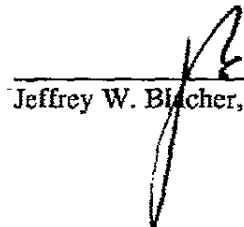
