Pursuant to the provisions of section 607.1006, Florida Statutes, the undersigned President of Keleske & Van Eepoel, P.A., a Florida professional corporation, hereby executes these Articles of Amendment to its Articles of Incorporation.

WITNESSTH:

WHEREAS, Keleske & Van Eepoel, P.A., a Florida professional corporation, filed its Articles of Incorporation on April 26, 2004; and

WHEREAS, Keleske & Van Eepoel, P.A., desires to amend and restate such Articles of Incorporation in their entity; and

NOW, THEREFORE, in consideration of the premises, such Articles of Incorporation are hereby amended and restated as follows:

ARTICLE I
NAME

The name of this Corporation shall be KELESKE & VAN EEOEL, P.A.

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of this Corporation shall be 423 S. Hyde Park Avenue, Tampa, Florida 33606.

ARTICLE III
CAPITAL STOCK

1. Authorized Capitalization. The total number of shares of capital stock authorized to be issued by this Corporation shall be Ten Thousand (10,000) shares of common stock, par value \$1.00 per share (the "Common Stock").

2. Payment for Stock. All or any part of the consideration for the issuance of the capital stock of this Corporation may be in cash, property, or labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for that purpose, which consideration, in any event, shall not be less than the par value of the shares issued therefor. All stock when issued shall be fully paid and nonassessable.

3. Voting. The voting power of this Corporation shall be vested solely in the Common Stock. Holders of shares of Common Stock shall be entitled to one vote for each share of Common Stock. There shall be no cumulative voting in the election of Directors.

4. Dividends. Any and all dividends are to be shared among the holders of shares of outstanding Common Stock on a share for share basis.

ARTICLE IV
EXISTENCE OF CORPORATION

This Corporation shall have perpetual existence.

ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of this Corporation shall be located at 423 S. Hyde Park Avenue, Tampa, Florida 33606, and the initial registered agent of this Corporation at such office shall be Joshua T. Keleske. This Corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.

ARTICLE VI
BOARD OF DIRECTORS

The Board of Directors of this Corporation shall consist of a number of Directors to be fixed from time to time by the stockholders or the bylaws. The business and affairs of this Corporation shall be managed by the Board of Directors, which may exercise all such powers of this Corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the stockholders.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

The initial Board of Directors of this Corporation shall consist of two (2) members, who shall hold office until a successor has been duly elected and qualified. The names and street addresses of the initial Directors are:

The provisions of Section 607.0901, Florida Statutes, relating to affiliated transactions, shall be inapplicable to this Corporation.

These Articles of Amendment to the Articles of Incorporation were approved by the shareholders. The number of votes for these Articles of Amendment to the Articles of Incorporation was sufficient for approval. The undersigned has executed these Articles of Amendment for the uses and purposes therein stated to be effective immediately.




