ARTICLES OF INCORPORATION OF LONGWOOD SHEETMETAL PRODUCTS, INC.

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing with the Florida Secretary of State the following Articles of Incorporation for the purpose of organizing a business corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION

The name of the corporation ("Corporation") is Longwood Sheetmetal Products, Inc.

ARTICLE II

ADDRESS OF CORPORATION

ARTICLE III

DURATION AND PURPOSE

This Corporation shall commence as of the date of the filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence. CAPITAL STRUCTURE

There shall be a board of directors for this Corporation that shall consist of not less than one (1). Except for the number constituting the initial board of directors, the number of directors shall be decided by the resolution of the shareholders. The powers to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors of the Corporation.

ARTICLE X

PRE-EMPTIVE RIGHTS
