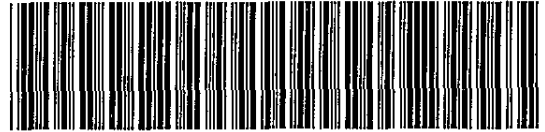

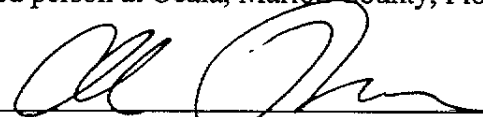
ARTICLE VIII

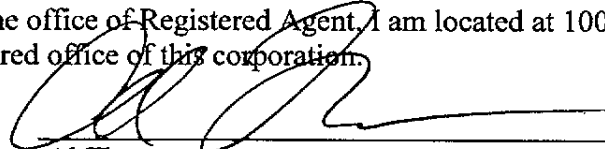
ARTICLE IX – PRE-EMPTIVE RIGHTS

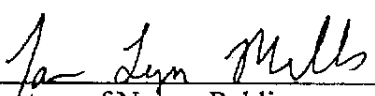
