ARTICLES OF INCORPORATION

OF

DOGE, INC.

TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: DOGE, INC., 500 N. Oleander Avenue, Daytona Beach, Florida 32114.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.


