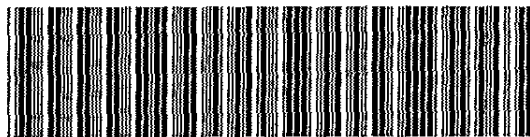

ARTICLES OF INCORPORATION
OF
DOYLE STEPHENS PAINTING, INC.

The undersigned subscriber of these Articles of Incorporation, the natural persons to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be DOYLE STEPHENS PAINTING, INC.

ARTICLE II. ADDRESS

The mailing address of this corporation shall be 19 Oakland Avenue, Oakland, FL 34760.

ARTICLE III. DURATION

This corporation shall exist perpetually or until such time as it may be dissolved in accordance with existing laws.

ARTICLE IV. PURPOSE

This corporation is to engage in all lawful businesses, including all powers necessary or convenient to effect its purposes as a contractor doing painting and pressure washing.

ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue ONE HUNDRED (100) shares of ONE AND NO/100 DOLLARS (\$1.00) par value common stock.

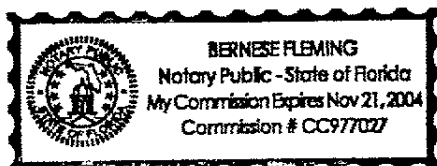


