## ARTICLES OF INCORPORATION

## **ARTICLE I - NAME**

The name of this Corporation is IGNAS CONSTRUCTION INC. (hereinafter referred to as the "Corporation")

# **ARTICLE II - DURATION**

This Corporation shall exist perpetually, commencing upon the filing of the Articles of Corporation by the Department of State.

### ARTICLE III - PURPOSE
