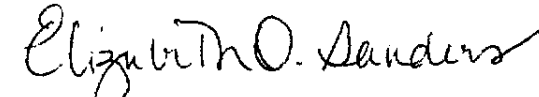

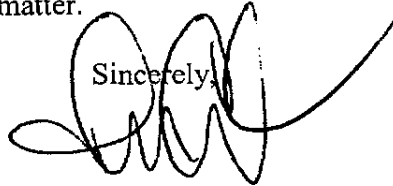

Thomas C. Ormerod, the undersigned desiring to form a corporation for profit pursuant to the laws of the State of Florida, does hereby certify as follows:

ARTICLE I - NAME

The name of the Corporation shall be Jet Trans, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business is: 9437 Corporate Lake Drive, Tampa, FL 33635.

ARTICLE III - MAILING ADDRESS

The mailing address for the corporation is 707 N. Franklin Street, Fourth Floor, Tampa, Florida 33602.

ARTICLE IV - PURPOSE

The Corporation shall be entitled to engage in any activity or business permitted under the laws of the State of Florida, specifically in providing transportation services of goods and products.

ARTICLE V - SHARES

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time shall be 1,000 authorized shares of One Dollar (\$1.00) par value, all of which shall be common stock of the same class. All stock issued shall be fully paid and non-assessable.

ARTICLE VI - INITIAL OFFICERS AND/OR DIRECTORS

The business of the Corporation shall be managed by its Board of Directors. The number

of Directors constituting the entire Board shall not be less than one (1) nor more than five (5) and subject to such minimum may be increased or decreased from time to time by Amendment of the By-Laws in a manner not prohibited by law. Until so changed the number shall be two (2).

The name and street address of the first Board of Directors, who, subject to the provisions of the Articles of Incorporation, the By-Laws of this Corporation and the laws of the State of Florida shall hold office for the first year of the Corporation's existence or until his successor is elected and has qualified, are as follows:

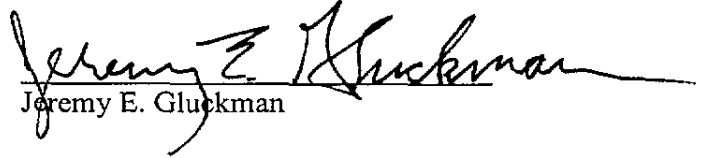
