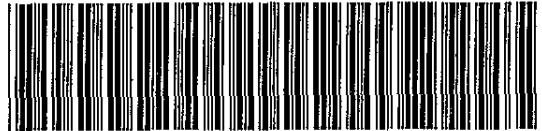

PURSUANT TO CHAPTER 48.091, FLORIDA STATUTES, CHARLES E WOODY OF 12240 TREETOP COURT ORLANDO, FLORIDA 32832 IS HEREBY NAMED AS REGISTERED AGENT OF THIS CORPORATION TO ACCEPT SERVICE OF PROCESS WITHIN THE STATE OF FLORIDA. THAT CHARLES E WOODY BY EXECUTION OF THESE ARTICLES DOES ACCEPT TO ACT IN THIS CAPACITY AND AGREE TO COMPLY WITH THE PROVISIONS OF SAID ACT RELATIVE TO KEEPING OPEN SAID OFFICE LOCATED AT THE ABOVE ADDRESS.


#### ARTICLE XI




