Last year I was not notified I needed to file a renewal. My accountant looked into the matter and was told by the state that I just needed to send in the regular \$150.00 fee. I did this on June 13, 2005 with check # 1056 and the check was cashed three days later by the state.

When I called the Division of Corporations, I spoke with Mr. Tyrone Scott, and he confirmed that I simply needed to send in the \$150.00 fee by September 7, 2005. When I went online today to file and pay for my 2006-2007 fee, I saw that my corporation had been dissolved on 9-16-05.

Mr. Scott directed me to send in the attached form with this letter to resolve the matter, along with the \$150.00 fee for the new filing period (2006-07) and \$8.75 to get a record.

Since I have fully complied with what the state instructed my accountant and myself to do and since state records indicate the same agreement, I formally request that any late fees be waived and the enclosed \$150 be accepted as the 2006-07 period.
