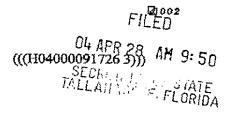

Articles of Incorporation of

ASK Chemical & Supply, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1: Name. The name of the Corporation is: ASK Chemical & Supply, Inc.
