The undersigned incorporators hereby associate themselves together to form a corporation under Chapter 607, Florida Statutes.

ARTICLE I
NAME

The name of the corporation is STEVEN J. RICHEY & ASSOCIATES, P.A., and its principal place of business is 601 South Ninth Street, Leesburg, Florida 34748, with a mailing address of Post Office Box 492460, Leesburg, Florida 34749-2460.

ARTICLE II
GENERAL PURPOSE

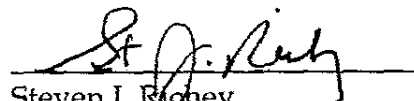
