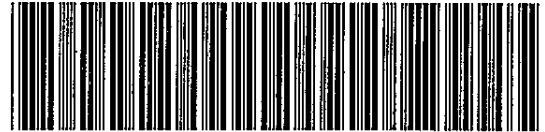



**ARTICLES OF INCORPORATION  
OF  
AIXA MOORE, P.A.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the Corporation ("Corporation") is AIXA MOORE, P.A., and the principal address and principal place of business is 6601 BLACKFIN WAY, APOLLO BEACH, FLORIDA 33572.

**ARTICLE II - PURPOSE**

The purpose of the corporation is to engage in the brokering of real estate transactions in the State of Florida.

**ARTICLE III - REGISTERED OFFICE AND AGENT**
